FEDERAL TAX CREDIT

Receive a **DOUBLE TAX WRITE-OFF** by donating your excess inventory may seem too good to be true, but many successful corporations receive it every year. Under the 170(e) law, you may deduct not only the base cost of your inventory, but one half of your potential profit (limited to double the cost) when you donate it to a qualified not-for-profit organization.

Elcom's non-profit affiliate accepts bulk shipments of excess inventory and redistributes it to other companies, mainly not-for-profit organizations, in smaller quantities that suit their need. There is *NO CHARGE* to the donor for this service. Our affiliate qualifies as a 501(c)(3) and is certified to accept items under article 170 of the IRS code.

Consider the benefits of donating your excess inventory:

- Up to a DOUBLE TAX WRITE-OFF. Many companies net more cash in saved taxes than can be realized by liquidation.
- Increase *Inventory Turns* and decrease *Days Cost of Goods Sold in Inventory* by purging non-moving products
